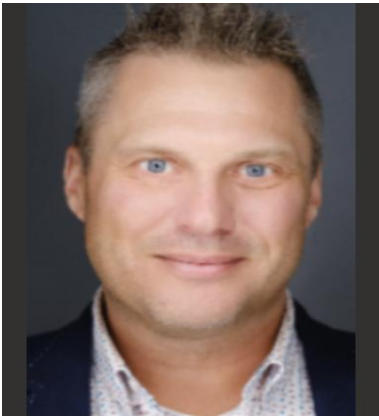
### **Background: Including Relevant Information/Professional Background/Reason for Running:**
